**Observations:** An unannounced visit was made to this Center to follow up on violations regarding supervision and staff/child ratios cited on 11/7/05 during your annual compliance visit. The assistant owner assisted me with this visit in the absence of the owner. During today's visit, ratios were in compliance. No incidents regarding lack of supervision were observed. You stated that an additional full-time staff person has been hired and will begin work on Thursday, November 17th to correct the potential staff/child ratio and supervision issues. I reviewed staff/child ratio and supervision requirements with you and with a newer staff member during this visit. Staff records were reviewed today. Two violations of child care requirements were cited and reviewed with you as follows:

**Violations:**

Item#	Comment
108	The operator made attempts to falsify information. A "false" BSAC training certificate was on file for a staff who works with school age children. This is a violation of a requirement in G.S. 110-91(14).
1445	All group leaders were not at least 18 years of age and had not completed or were enrolled in BSAC training. An individual providing care for school-age children does not have an official BSAC training certificate on file. This is a violation of a requirement in .2510(c).

**Comments:** To meet child care requirements, all violations must be corrected immediately and a signed letter mailed to me by 11/29/05 describing how each item number was corrected. Please include your facility ID number and mail to: Audrey Davis PO Box 472 Winston-Salem, NC 27102

**If the operator fails to correct any documented violations within the established time period, the Division of Child Development may deny, suspend, terminate, or revoke any permit to operate (10A NCAC 09 .2000).**
